### **About the New Members of 2021-2022**

**Sharon Cooper, Ph.D,** is a leading behavioral psychologist at John Hopkins Sibley Memorial Hospital Center for Weight Loss Surgery (2006 – present). With more than 30 years of expertise as a licensed psychologist in private practice, she also served at such organizations as Arlington Psychiatric Group, Institute for Human Resources and Center for Family Research. Sharon has developed a successful individual practice helping many people toward better mental health. As a coach, Sharon helps people determine and fulfill their goals.

**Alissa Fox** is currently a health policy adviser for Limber Health, a digital health startup. Prior to that, she was the senior vice president and head of the D.C. government relations office for the Blue Cross Blue Shield Association. She is a member of the American Psychological Association, the American Association for the Advancement of Science, and the Women's Research & Education Institute. Melanie is active with the Caribbean Association of the World Bank Group and International Monetary Fund Staff and the John F. Kennedy Center for the Performing Arts.

Margaret VanAmringe is the executive vice president for public policy and government relations at The Joint Commission, a U.S.-based nonprofit organization that accredits more than 22,000 U.S. health care organizations and programs. Prior to taking a position with the Joint Commission, Margaret was director of the Center for Research Dissemination and Liaison at the Agency for Health Care Policy and Research (now the Agency for Health Research and Quality) in the U.S. Public Health Service, Department of Health and Human Services (DHHS). There she established the agency's first health information dissemination program to bring practical information gleaned from health services research into the hands of consumers and their families. Margaret holds a master of health sciences degree from the Johns Hopkins Bloomberg School of Public Health.

**Anne Wengrovitz** is a public health professional with more than 25 years of experience developing and implementing strategic policy and program solutions. She is currently a director at Humanitas, where she manages consulting projects for federal agencies, private companies and nonprofit organizations. From 1992-2004, she served as director of health policy and then deputy director for the Alliance to End Childhood Lead Poisoning. She co-authored two manuscripts published in the Center for Disease Control weekly scientific publication. Anne held several leadership positions with the Arlington Philharmonic, including board president, and founded the Arlington Youth Orchestral Program, overseeing its merger with the Arlington Philharmonic.

### Treasuring the Process: Jackie Hunt's Corporate and Personal Adventures

Born in Bedford, Pennsylvania, Jackie Hunt has called the DC metro area home for most of her life. At the age of 10, she relocated here with her family when her father applied for and received a position with the Government Printing Office. Prior to that, he, as well as his family, had worked in coal mining. His father was a Welsh immigrant that began working in the Pennsylvania coal mines at the age of eight. Jackie's father decided that he needed to change his vocation to offer greater opportunities for his family, hence his decision to move to the DC area. It was a good decision as Jackie became the first on her father's side of the family to earn a college degree.

For Jackie, a college education was not just the next point in a series of expected consecutive benchmarks; it was a gamechanger. Hunt had married her high school boyfriend and was raising two young sons by the time she went back to college. "I went back to college while my kids were little; it took a long time but I got my bachelor of science degree from University of (UMD)." Maryland Though she simultaneously earning her degree, caring for two children, and entering the work force, Hunt continued to advance at the aerospace company for which she worked as a system analyst.

After graduating from UMD, Hunt continued her work at the aerospace company, eventually moving to the corporate offices to work directly for the vice president. Later, Martin Marietta, one of largest aerospace and technology companies













at the time, offered her a job, where she responsible for pursuing technology programs with the federal government. Next came a tug of war: Hunt was recruited to work with a research and development company as a vice president of business development. After several successful years, she was recruited back to Martin Marietta by her former boss, as director of business development in the information systems division. While in this position, her responsibilities increased as merged to Martin Marietta become Lockheed Martin. She again found more opportunity when Science Applications International Corporation (SAIC) offered Hunt a vice president position at the corporate level. While there, she was promoted to corporate vice president working across all the SAIC business entities. During that time, SAIC grew to be an 11billion-dollar research and development company.

During this tug of war, Hunt's personal life changed as well. Her kids grew up, she and her husband divorced and, in 1995, Hunt met her second husband, Robert Slahetka and they married in 1997. "He's the kindest,

most sincere, caring person I have ever met in my life." It was Robert to whom she turned when her granddaughter was born, lamenting over how she worried she would miss out due to the obligations that came with her work. "He said, 'Well, quit!"' She said, "I can't do that!" Hunt found a third option. She became a consulting employee. Two days a week, she watched her granddaughter. The remainder of her career focused predominantly on strategic planning, determining bidding budgets and developing customer relationships. She and her husband subsequently invested in a CPA firm where they both worked to help the company grow providing financial management services to the federal government. A few years ago, they divested their ownership and retired.

Today, she once again finds herself involved in financial management, as treasurer of Charter 100 DC, a post she has held for four years. "One of my dear friends, and former industry associates, Kay Myers belonged to Charter 100, and she said, 'You know this is a great group of women, and we have a great time." She agreed. "I enjoy the fellowship with other women who have had very interesting careers." In addition to her work with Charter 100, Hunt volunteers her expertise to a variety of charities, including, most recently signing up to volunteer at the Shepherd Center that provides various services to the elderly. She is also as devoted a grandmother as ever, only now to four grandchildren.
